## LOYALTY OFFER PERIOD FOR RETURNING ATHLETES

(48 HOUR OFFER)

JULY 6 to 9, 2026 | PGH Clubs July 4 to 7, 2026

Clubs are permitted to send Loyalty Offers to returning athletes who will be participating in the 12U-18U age divisions for the upcoming season. A returning athlete is defined as a registered KRVA member assigned to a registered KRVA club during the previous year/season.

- Offers are only valid when emailed using the KRVA Loyalty Offer criteria found in the Cub Directors manual.
- All fields should be filled out to the best of the club's ability using the information available at the time. Clubs may add more detail as desired, or details specifically negotiated with the parent(s). If there are any changes, or there is a failure to meet the terms, the offer may be voided.
- All re-signing offers must be honoured for 48 hours from the time indicated on the email.
- Clubs **MUST** provide a list of re-signed athletes to KRVA for posting by the Thursday prior to Summer Tryouts.
- Member Registration will be made available beginning September 6th for re-signed athletes.
- Athletes are permitted to begin team activities once they have been re-signed.
- **Re-signed athletes are committed to the club for the season and are NOT permitted to attend any tryouts for other clubs.**
- Athletes who attend additional tryouts after accepting a KRVA Early Re-Signing email will be found in violation of this policy and may be subject to sanctions/penalties as outlined at the end of this document. All verbal offers are informal and NON-BINDING.

## **SUMMER TRYOUTS & OFFER WINDOW**

### **JUNIOR GIRLS 15 & OLDER | JUNIOR BOYS**

All athletes complete their commitment to their current club at the end of GJNC of each season. After this date athletes are permitted to begin researching and possibly training with new clubs.

Club tryout dates will be set and published no later than January each season. All tryouts MUST be sanctioned by the KRVA office. All tryout proposal(s) must be submitted using the KRVA Site Sanction Form on the KRVA website.

#### **Junior Boys**

- First available date clubs can hold tryouts: July 18, 2025 | July 24, 2026
- Email offers can be sent out on July 18, 2025 | July 24, 2026
- All offers made after July 18, 2025 | July 24, 2026 are at the discretion of the club

#### **Junior Girls 15 & Older**

- First available period clubs can hold tryouts: July 18 to 27, 2025 | July 17 to 26, 2026
- Email offers can be sent out Wednesday @ 7pm on July 23 to Aug 1, 2025 | July 22 to 31, 2026
- **Clubs Located with 75 miles of Pittsburgh**
  - Tryouts Starting July 5<sup>th</sup> to 27, 2025 | July 10 to 26, 2026
  - Email offers @ 7pm on July 5 to August 1, 2025 | July 10 to 31, 2026
- No tryouts may occur between July 28 to November 6, 2025 | July 27 to November 5, 2026
- No offers permitted between August 2 to November 11, 2025 | August 1 to November 10, 2026

There is a \$50 tryout sanction fee for each proposal. Fee(s) must be paid to the KRVA Office BEFORE tryouts are sanctioned. All players and coaches in attendance are required to have a current USAV membership.

All offers must be sent via email on the Summer Offer criteria. All required fields should be filled out to the best of the club's ability using the information available at the time. If there are any changes in the terms on the form, or there is a failure to meet the terms, the offer may be voided. All club-initiated offers are valid for 48 hours as per the time on the email.

**Athletes that commit to the club with by accepting a Loyalty Offer via email, are NOT permitted to attend any tryouts for other clubs.** Athletes who attend additional tryouts after accepting a Loyalty Offer to a club will be found in violation of this policy and may be subject to sanctions/penalties as outlined at the end of this document. All verbal offers are NON-BINDING.

## **FALL TRYOUTS & OFFER PERIODS**

### **JUNIOR GIRLS**

Club tryout dates will be set and published no later than January each season. All tryouts MUST be sanctioned by the KRVA office. All tryout proposal(s) must be submitted using the KRVA Site Sanction Form on the KRVA website.

#### **Junior Girls 14 & Under**

- First available date clubs can hold tryouts: Friday October 17, 2025 | October 16, 2026
- Email offers can be sent out on Wednesday @ 7 PM October 22, 2025 | October 21, 2026
- All offers made after 7:01 pm October 22, 2025 | October 21, 2026 are at the discretion of the club

#### **Junior Girls 15 & Older**

- Clubs can hold tryouts: Friday November 7, 2025 | November 6, 2026
- Email offers can be sent out on Wednesday @ 7 PM November 12, 2025 | November 11, 2026
- All offers made after 7:01 pm November 12, 2025 | November 11, 2026 are at the discretion of the club

There is a \$50 tryout sanction fee for each proposal. Fee(s) must be paid to the KRVA Office BEFORE tryouts are sanctioned. All players and coaches in attendance are required to have a current USAV membership.

If a Loyalty Offer was accepted by an Athlete and their Parents/Guardians, those athletes are not eligible to attend another clubs' tryouts other than the club they accepted the Loyalty Offer with. These athletes accepted binding offers to a club for the upcoming season. Sanctions will be imposed if an athlete goes to another clubs' tryouts, or if coaches are found to be recruiting athletes to another club's tryouts.

Junior Girls offers may not be sent prior to the Wednesday following tryouts at 7 pm. Any offer sent prior to that will be considered non-binding (GIRLS CLUBS ONLY). Offers can ONLY be sent out via email at the times indicated above.

All offers and acceptances must be emailed using the KRVA Offer criteria and cc'd to [offers@krva.org](mailto:offers@krva.org)

All offers must be honored for 48 hours from the time indicated on the email.

Clubs are permitted to continue to hold additional tryouts to fill any open spots on their rosters

## ADHERENCE

The Keystone Region reserves the right to investigate any possible tryout window infractions regardless of how the KRVA learns about the incident. This is a self-policing policy and all KRVA members are obligated to report any infractions and cooperate fully with any investigations. If the KRVA determines that an offense has occurred, there will be a fine of \$500 per occurrence and any of the following sanctions may also be imposed, depending on the severity of the offense:

- Letter of reprimand.
- Indefinite suspension of the individual, team and/or club from KRVA events, beginning from the date when the investigation concludes.
- Individuals, teams, and/or clubs suspended for more than one year must apply in writing for reinstatement as a member in good standing. Approval for reinstatement will be contingent upon a full review of the application by the KRVA.
- An individual, team and/or club may appeal a sanction or fine through the KRVA Appeals Policy.

When reporting a possible infraction please include the following information:

- Date of infraction and offending club.
- Any type of objective documentation that supports a violation to the policy, includes but not limited to:
  - Website links and or social media posts
  - Emails and/or texts
  - Publications (newspaper ads, flyers etc.)
  - Receipts
- Contact information for the person reporting the incident.
